## Re: Fast Interface for New Issuance FINI

We refer to the announcement of HKEX, the Fast Interface for New Issuance FINI will be officially launched on 22 November 2023.

Under the FINI, when you subscribe for IPO shares, Shanxi Securities International Limited ("SSIL") will have to obtain your express consent to collect and process your client identification data ("CID"), and authorizes the Company to submit your identity information when processing IPO subscriptions. Upon the launch of the FINI, without obtaining your express consent will result in SSIL cannot process your IPO subscriptions ultimately. Please note and reply at your earliest convenience.

For the customers who opened an account on or before 31 May 2022 and have already replied to the form << The HKIDR and the OTCR Personal Information Collection Statement and Client Identification Data Reply Slip>> sent from SSIL, you do not need to reply again since the form has included express consent of FINI. However, if you have not replied yet, please reply to SSIL via one of the following methods as soon as possible.
